Details: A comprehensive search was conducted by the Pittsburgh office to locate any materials pertaining to the Kennedy Assassination. Pittsburgh's searches which were limited to records of this Division included the automated indices, manual indices, elsur indices, confidential indices, and Intelligence Integrated Information Application (IIIA). A CLEA search was not conducted by the Pittsburgh office.

Based upon this search, Pittsburgh located file 62-3721 which was not previously reported to FBIHQ. This file is captioned "ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, DALLAS, TEXAS, NOVEMBER 22, 1963, MISCELLANEOUS - INFORMATION CONCERNING, OO: DALLAS." An indices card which was prepared 11/83, captioned "THE KENNEDY ASSASSINATION AND BEYOND (PART 1)" was also located. This card contains a reference to a law enforcement bulletin (LEB) article #11, Volume 52, November, 1983. The Pittsburgh office only maintains file copies of the LEB dating back to 1991.
