Details: (S) For the information of the Bureau, re EC dated 4/20/98 from Brian J. Fields, [247B-CG-3] Source CG-S [13975] is not being forwarded to FBIHQ due to the fact that PLS Trecek reviewed requested file and it was found to be not identifiable to President John F. Kennedy. The material requested concerned a Professor John F. Kennedy from the University of Notre Dame. The following original serials are enclosed 92-350 Sub U-51, dated 11/20/62, Serial 134-1369, dated 10/16/61 and Serial 157-1291 Sub D, dated 10/13/71 (EC from Task Force gave a date of 10/13/81 but case was closed in 1972 and logs did not exist in 1981.
