Enclosures: Enclosed for FBIHQ are 13 original serials.

Details: The enclosed thirteen serials were located on a special search among the numerous volumes of file 92-116. The enclosed original serials were filed with the enclosed charge out dating back to May of 1966.

The majority of the original serials of 92-116 Sub A were charged out to FBIHQ on May 9, 1966. Copies of these were made and retained by Kansas City. However, for an unknown reason, a new 92-116 Sub A file was created for the duplicates. As a result, two 92-116 Sub A files were in the Kansas City Office: one with the forwarded copies; the other with the retained originals.

The file containing the copied serials was correctly placed in numerical order in closed files. Unfortunately, as the file containing the few retained originals was extremely thin, it was misfiled in another volume of the file. As a result, when the initial searches for the missing serials were conducted, the file containing the copied serials was quickly located, leading to the assumption that Kansas City no longer had the missing original serials. Only through the instant complete and exhaustive search of the entire file were the misplaced original serials located.
