Title: John F. Kennedy Records Collection
Act of 1992 (the Act)

Synopsis: Chicago is requested to forward the documents listed below to the JFK Task Force as soon as possible due to an extremely short deadline.

Details: Pursuant to the John F. Kennedy Assassination Records Collection Act of 1992 (JFKARCA) any material considered assassination records must be made available to the National Archives and Records Administration (NARA) in their original form. The JFKARCA defines how the FBI may now postpone certain information, but the originals are still sent to the NARA, to be maintained until the year 2017 when they are to be opened in full. Therefore, the serials will not be returned to Chicago.

Since the originals will be sent to the NARA, copies of the serials should be made for record purposes prior to shipment to FBIHQ. The serials should be received at FBIHQ no later than C.O.B. 05/29/98.
