Synopsis: Detroit is requested to conduct a search for documents listed below to and forward the documents or an EC confirming that the documents are not located at Detroit to the JFK Task Force as soon as possible due to an extremely short deadline.

Details: By EC on 08/29/97, Detroit provided file chargeout forms regarding files that were forwarded to the JFK Task Force in 10/96. Among the files requested and forwarded was Detroit file 92-914. The file chargeout form does not specify the volumes sent to Headquarters but indicates "all" volumes were charged out and forwarded to the JFK Task Force.

The JFK Task Force is currently in possession of Detroit file 92-914 with the exception of volumes 1 and 2, serials 1-15. A search of the Detroit field files currently at Headquarters was negative for volumes 1 and 2 of 92-914.

The JFK Task Force requests that Detroit conduct a search specifically for Volumes 1 and 2 of File No. 92-914 and notify the Task Force by EC of the results of the search, and forward the documents if located. Detroit's reply should be received at FBIHQ no later than C.O.B. 06/03/98.
