Synopsis: Miami is requested to check its files and indices for the document listed below and, if it can be located, forward it to the JFK Task Force as soon as possible due to an extremely short deadline.

Enclosure: Copy of Serial One from File No. 65-3346.

Details: On 4/28/98, the JFK Task Force (JFKTF) sent an EC to Miami requesting that the original of Miami file 65-3346, serial 2, be forwarded to Headquarters. In a phone call on 4/30/98, Miami informed JFKTF that closed 65 files in the Miami office ended at 3343.

JFKTF is in possession of Miami file 65-3346, serial 1. A copy of this serial is forwarded with this communication as it may assist Miami in the search for Serial 2. JFKTF records indicate that Serial 2 may be dated December 1976.

Pursuant to the John F. Kennedy Assassination Records Collection Act of 1992 (JFKARCA) any material considered assassination records must be made available to the National Archives and Records Administration (NARA) in their original form. The JFKARCA defines how the FBI may now postpone certain information, but the originals are still sent to the NARA, to be maintained until the year 2017 when they are to be opened in full. Therefore, the serial will not be returned to Miami.

Since the original will be sent to the NARA, a copy of the serial should be made for record purposes prior to shipment to FBIHQ. The serial should be received at FBIHQ no later than C.O.B. 05/18/98.

If 65-3346-Serial 2 can be located, ship to FBIHQ, JFK . Task Force, Attention Catherine L. Lamey, Room 11144.
