Details: This communication is to advise the JFK Task Force what steps the New Orleans Division will take before forwarding the requested documents to the task force.

New Orleans will inventory and prepare a list of all Title III transcripts. As each box of transcripts are inventoried, they will be forwarded to the Task Force so that they can be copied. New Orleans will make a copy of the Title III logs and forward these logs to the Task Force since a copy must be maintained by the New Orleans Division (these are our only copies) for retrieval purposes should New Orleans be required to respond to other requests regarding this case. Transcripts found for consensual recordings will be forwarded to the Task Force for copying.
