**Details:** Pursuant to the John F. Kennedy Assassination Records Collection Act of 1992 (JFKARCA) any material considered assassination records must be made available to the National Archives and Records Administration (NARA) in their original form. The JFKARCA defines how the FBI-may now postpone certain information, but the originals are still sent to the NARA, to be maintained until the year 2017 when they are to be opened in full. Therefore, the serial will not be returned to Las Vegas.

Since the original will be sent to the NARA, a copy of the serial should be made for record purposes prior to shipment to FBIHQ. The serial should be received at FBIHQ no later than C.O.B. 08/13/98.

Attached is a copy of the requested document. It was located in a copy of Las Vegas file No. 92-308-Sub 2, following serial 73. The raw file is at Headquarters in the possession of the JFK Task Force. The original of this page is not located in the raw file.
