The searches failed to locate any additional assassination related information regarding the above subjects except for two references to Jack Ruby. The references are identified as 174A-OC-56120 Sub D serial 26 and 174A-OC-56120 Sub S serial 569 and are contained in the OKBOMB investigation. A copy of each serial is enclosed for FBIHQ's review regarding their relevance to the Act.
