**Synopsis:** This communication reports the searches conducted by the Pittsburgh office for records pertaining to the John F. Kennedy Assassination.

Administrative: Reference is made to FBIHQ electronic communication (EC) dated 05/29/1998.

Details: On 06/03/1998, a search of the Automated Case Support (ACS) as maintained by the Pittsburgh office revealed Pittsburgh control file 190-PG-55339 which was indexed as a main file under John F. Kennedy. This control file was opened on FBIHQ teletype to all Field Offices dated 01/23/1992, and houses all correspondence between the Pittsburgh office and FBIHQ regarding Pittsburgh's searches and the results of those searches.

Pittsburgh's ACS contains no additional information pertaining to this matter.

All other attempts to locate materials pertaining to this matter which may have not been indexed to our central records system met with negative results.
