**Administrative:** (U) 62-HQ-1029205 FBIHQ EC dated 05/11/1998 (received at Brussels 06/22/1998 and not uploaded in ACS).

**Enclosures:** (X) (U) Enclosed for the Historical and Executive Review Unit, OPCA, is the referral sheet and copy of document attached originating with the Amsterdam Municipal Police.

**Details:** (U) Referenced EC sent to Brussels a cover letter and five referral sheets with copies of documents to be sent to the appropriate Belgian authority identified in the EC. However, one of the enclosed documents, DL 3372-286, was incorrectly included. As Brussels has previously advised, Amsterdam is a city in the Netherlands, a separate country which, although also in Brussels' territory, is not part of Belgium. The Amsterdam Regional Police (APD) would be the current successor to the Amsterdam Municipal police; however, because of the clear desire of the Assassination Record Review Board to remain independent, Brussels will not send the document to the APD but instead is returning

the document to FBIHQ. Brussels suggests that the document be forwarded to the Dutch Binnenlandse Veiligheid Dienst (BVD) through Leo Hartvelde, the BVD liaison officer in Washington who has regular contact with International Relations and Operations Branch (IROSB), FBIHQ.
