Re Los Angeles airtel to Bureau, Washington Field Office and Las Vegas 2-19-62 and Los Angeles teletype to Bureau and Washington Field Office 2-19-62.

The following information is of such a sensitive nature that it cannot be disseminated at this time because such dissemination would definitely endanger the life of the informant.

Referenced airtel described information supplied by LA 4350-C by telephone on 2-16-62 to SAA ALBERT A. HUSTEDT. At the earliest subsequent opportunity, the informant was interviewed at Los Angeles on the night of 2-19-62 at which time he supplied the following data to SAs ALBERT A. HUSTEDT (A) and LOGAN J. LANE, JR.:

At approximately 5:30 am on Friday, 2-16-62, the informant received a telephone call at Las Vegas, Nevada, from RICHARD (DICK) KAVNER and PETE SAFFO from Washington, D.C. KAVNER is an international organizer for the Teamsters Union and PETE SAFFO is a union representative, described by the informant as a "muscle man" for HOFFA. Both reportedly originated
