MISCELLANEOUS:

Reference is made to info in instant report pertaining to the men's suits allegedly being offered for sale by subject. It should be noted that several sources furnished info re this matter, which indicated that others besides FARRELL had access to the suits and were offering them for sale; further that the suits allegedly came into Iowa from Illinois. Inquiry of the Chicago and Springfield Divisions and in the Omaha Division failed to locate any info indicating a theft of a large number of men's suits had been reported in those areas. A case was opened under caption "UNSUB; 150 3G, Hickey Freeman and Kuppenheimer Suits, reportedly at Des Moines, Ia., said stolen Illinois, ITSP," OMfile 87-6112, which case now closed.
