he planned to do today. [KARPAN] (s) said he was going to work on the

SOK said that he would be glad to see MC but that right now would not be convenient. MC suggested that he will be back in town next Thursday and that maybe they could get together then. [SOK] (S) said that this would be fine at 4:00 pm. OK bwr

[WF 279-S] (S) PAUL KELLY speaks with [A.N. IZVEKOV] (S). IZ. says that they are ready to buy the new Mercury station wagon (Commuter). They want the 6 cylinder with automatic transmission and power (B & S), push button radio and electric clock. They want beige or ivory color. (No heater?) jfb

SAL. said that he probably would, but that there would not be any release following this meeting. bwr

[WF 279-S] (S) P.I. MARKOV (S) to NORMAN KOMISKEY, Secy to CYRUS EATON asking COM if there are any food prohibitions as related to MR. EATON. COM pointed out that EATON is a light eater; that he drinks little --- no coffee, some tea or hot water, sherry or a little scotch, and in general he eats what is placed before him (oh for the opportunity.....) (S) COM then asked if [MARKOV] (S) is the assistant to [A.E. DOBRYNIN] (S). Yes. He asked if [SOKOLOV] (S) is no longer with the ambassador. MARKOV said that [SOKOLOV] (S) is the Press Assistant. COM said that he would no doubt be talking with [MARKOV] (S) again and is very anxious to meet him. bwr
