Mr. SWANSON (PH) of Randolph Central High School, Randolph, NY to D. J. JOSIP PRESBURGER (S). He mentions that he has been in contact with PRESBURGER (S) by mail re the appearance of the Yugo ambassador before the faculty of the gih school on May 25. PRESBURGER (S) recalls him and says that it is arranged for the ambassador to appear at the school on May 25. SWANSON states that he is now in Washington D.C. touring with the senior class and that he would like to come over to the Embassy (S) sometime today to talk with PRESBURGER (S) re proposed financial arrangements. PRESBURGER (S) says that would be fine and they arrange for SWANSON to see PRESBURGER (S) at the Embassy (S) at 3pm today.

OREN RUZIC to DIONYSSIOS XENOS, GREEK Embassy. XENOS (S) said he hasn't heard from RUZIC (S) for quite some time and was worried that maybe RUZIC (S)'s illness has been getting worse. RUZIC (S) says that he's been getting better and that all is fine. He asks XENOS (S) if he is free tomorrow and is informed that he is. They arrange to lunch tomorrow XENOS (S) will drive by to pick up RUZIC (S) about 5 minutes to one tomorrow. XENOS (S) mentions that he'll bring by a lot of letters that have come for RUZIC. RUZIC (S) says fine.
