ANDREW TULLY to [YURI I. VOLSKIY]. TULLY stated he is a journalist and author (phone # 667-3318). Is writing a book about Soviet victory in Berlin in 1945 (S) Just returned from Germany (S) where he interviewed [GERMAN] soldiers and civilians who were involved in the battle. Now desires to obtain [Soviet] literature relating to same so he can present [Soviet] point of view in his book as well as [German] view. Mentioned he has tried to obtain visa to visit [USSR] to interview [Soviets] re battle without success. Also has previously tried to secure [Russian] cooperation in getting literature re battle without success. [VOLSKIY] said he was not aware of [TULLY'S] problems in this regard and will look into matter. [TULLY] asked for name of man in charge of press dept. [VOL] stated name was NIKOLAY V. DYAKONOV (S) who will be in Washington in two days. TULLY indicated the last book he wrote was about the CIA. ajs
