[SARATOV] (S) said he is leaving (did not say for where) in the morning, and had left word with [VLADIMIR KABYSHEV] (S) that he would be unable to make the appointment. N.V. said he hadn't seen [KABYSHEV] (S) because he had waited at Compress, where, he understood, they were to meet. (Russ.) (S) eid/dc

[JOHN BRYER] (ph) to [A.N. CHIZHOV] (S) telling him that the response has been overwhelming. Says that he'll send CH. a copy of the announcement via mail. Further states that the Washington Post is interested in doing a story on "it", and BRYER assumes that it will be OK to have a photographer to come along. Some of the people are so anxious to come that they would be happy to stand up during the first part of the program. He then reads in part the announcement: dinner reception Thursday the 14th, 7:00 -- 10:00 pm. Movie on Russia, talk on the Soviet methods of higher education, Question and answer period and then a cocktail hour when people will be able to mix and speak individually with the various guests. BRYER will call Tuesday for the final arrangements. There is talk of upping the seating arrangements to 140. (it is noted that the location of this dinner reception is not mentioned. However, it seems to be the [S.E.] (S) jfb

ZHILTSOV] (S) whole call was about material for current and future magazines, with the following exceptions: [ZHILTSOV] asked if YURI had heard from [TARASUTIN] (S). Yes, he had, and thanked [ZHILTSOV] very much. [YURI] then asked when "our MARK" will leave. [ZHILTSOV] said probably a week earlier than planned, about the 27th or 28th. [ZHILTSOV] asked when [NATASHA (DYAKONOVA)] (S) would be leaving (to come to Wash.?) and was told about the 18th. [YURI] asked [ZHILTSOV] if he had rec'd the "Thanksgiving program" (not further identified). Yes; and it was excellent. (Russ.) (S) dc (S)

She says that they will be able to tape it in advance, and that [DOB] (S) can then look at the tape to see if it agrees with him. The interviewers will be JOHN SCALLI and RAULSON (ph) or ED MORGAN. [SOK] (S) says that he'll check and let her know about how [DOB] (S) feels about it. jfb
