Two [Unid Males] -- Arabic for translation. Called believed to be [AMBASSADOR BENGELLOUN.] Part of this conversation is in French. The AMB. BENGELLOUN speaks to several people. The third is named [MOHAMED.] [MOHAMED] says he is operating normally in this country. He adds there are certain technical difficulties in his project which he describes as big. [MOHAMED] says his troubles stem from the fact that Americans have confidence only in the dollar and ## therefore he must have many dollars behind him to do anything. He is critical of the general organization of Americans and declares it takes too long to get anything done here. [MOHAMED] adds however, that he does have certain American friends who are helping him in his project. He refers to his project here as being something extraordinary to help acquaint people with [Morocco.] Could be referring to a World's Fair Project. [MOHAMED] says those in authority in [Morocco] understand his problems here to the extent that within [48 hours] they sent [100,000 in dollars,] to him.

[BENGELLOUN] says PRINCESS IESHA (phn) is arriving in [WDC#] on Saturday. He explains that the PRINCESS is now in Miami to see JACKIE KENNEDY and to give to her, in behalf of the KING, a "Mazor (phn) of Marakesh." BENGELLOUN invites [MONAMED] to a dinner he will give for the PRINCESS on Saturday.

[Unid Male] for PRINCESS IESHA in Miami to [EL GLAOU] advising that the PRINCESS and her entourage arrive [WDC] on flight #208, National Airlines, on Friday at 4:45pm in WDC. Unid says they see MRS. KENNEDY this afternoon at 6pm. EL GLAOU requests that unid call him again right after the meeting of the PRINCESS and JACKIE so they can get some publicity on this.

Then AMB. BENGELLOUN speaks to [Unid Male] to ask how long the PRINCESS will be here. Unid advises she will leave Saturday evening for Paris. Unid requests that BENGELLOUN make reservations in this regard for 4 first class tickets and 1 economy from WDC to NYC. From NYC to Paris he requests 3 first class and 1 economy explaining that he will stay in NYC.

Then EL GLAOU speaks to [MR HASSAN (phn)]. HASSAN tells ELGLAOU to make sure the above mentioned plane reservation are on either [Pan American or TWA]. He emphatically states he does not wish to travel [Air France].
