C-6[AVNER IDAN] to MR. SELINGER (sp), NYC, CI 7-7000. (S)
[IDAN] tells S, in reply to the latter's question, that he doesn't know what
has been done at the Embassy, having just arrived at the Embassy. S relates
that the situation is as follows: S met with [this Jew] (S) "R", and the latter
thinks that there is no point in S going to the Embassy before "he" should have
a talk with [the Gentile] (S) with "SM". [IDAN] asks why that is and S replies that
"he" (R ?) has that opinion. S feels that this position is not correct and that
it is necessary simply to find out what the Embassy has done and what the reac-
tion was, in order to make it possible to arrange somewhat the visit and the ac-
tivity. S would like [IDAN] to give his immediate attention to this and advise
S because S wants to begin to go to work without further delay. S wants to know
if they made the approach and what the reaction was. S thinks that the matter (S)
resolves itself into two points: one, that S wants to obtain copies of the trials
that took place and there should be no problem there; and second, the same things
that everybody saw. [IDAN] will see what the situation is and advise S around
11:30 at the hotel. (S) (HEBREW) AEC9:59am
nc[NATHAN BAR-YAACOV] to HERMAN EDELSBERG, B'NAI B'RIT, (S) saying that he would like to
delay their luncheon appointment to 1:15 today at the same place. Agreed. AEC10:07am

is any such letter and requests that a copy of any such letter be sent to [ARNON] (S)
whenever [HORN] writes a letter to MOSS. [RUTH] notes [ESHKOL] is arriving AEC

this afternoon and he and [LAHAV] agree to meet at the UN, in the Delegates (S)
Lounge, at 3 this afternoon. [LAHAV] is leaving Wash. for NYC at 1PM. AEC10:20am
nc[DR. LAHAV] (S) to [SHOSHANA BAR-TUV] (ph), NYC, advising that he's coming to NYC this
