Authority granted NYO for Solon to accept the \$5,000
if offered. Arrange with Solon to receive any money which may
be offered him and retain it as evidence. (S)(u)

NYO immediately institute full-scale investigation
of captioned organization to determine its current background,
including identities of its officers and members; the nature
of its past and present activities; the location of any branches;
the source of its funds; and the identities of any individuals
seeking to contribute money to the furtherance of its activities
or contacted in this regard. NYO locate and review any bank
accounts of captioned group as well as those of its officers and
key members. Where warranted, open separate investigations on
individuals connected with captioned group to identify them and
to determine the nature of their activities.

NYO intensify efforts to identify George Adams,
Mrs. Byron, and the group Adams allegedly represents. Adams
may be identical with the George Adams mentioned in NYlet
3-29-57 captioned "Consulate of Egypt, NYC." No definitely [S]
identifiable information concerning Mrs. Byron was located in
Bufiles. [62-101947-492] (S)

Miami Office also conduct investigation to determine
the activities of captioned group and to identify Adams. (S)(u)
