In view of the fact that no information has been developed through contacts with reliable law enforcement agencies and with informants who are in a position to have such information, that the subject is involved at the present time in any illegal activity, UACB, no further investigation is being conducted in this matter. Should information be received from any source whatsoever that CAMPISI is involved in any illegal activity, this case will be immediately reopened for investigation and the Bureau kept advised of pertinent developments.
