The Italian National Police advised Legat on September 10, 1971, that to date Italian police in Salerno, Italy, have been unable to verify that subject visited that city. According to the Italian National Police, it has alerted principal police districts throughout Italy to our interest in subject and will furnish to Legat expeditiously any information which may be developed relating to subject's travel in Italy.
