For information San Antonio and WFO, subject and a close friend, FRANK LA COKE, made a trip to Italy in the past year. Central Bureau, Criminal Division, Italian National Police have requested photographs and fingerprints of CAMPISI and LA COKE.

Dallas files reflect that FRANK LEWIS LA COKE was fingerprinted by the State of Texas for a driver's license applicant card number C8587. Dallas files contain newspaper photograph of LA COKE, which is over ten years old. New Orleans Office, where LA COKE formerly resided, has been advised by the U. S. Passport Office there that all passport records and photographs are forwarded to their Washington, D. C. Office and any record or photograph of LA COKE can be obtained there. Dallas files contain no description of LA COKE except that at one time he resided at 2104 Lafayette Street, New Orleans, Louisiana.
