2. Will interview the subject concerning his current activities and determine his attitude with regard to furnishing information.

ADMINISTRATIVE

On 10/14/66, LA 4448-C-TE positively identified the photograph of JOHN ROSS PATRONO as being identical with the individual introduced to him several years ago at Hollywood Park Race Track as JOHN RUSSO or JOHN ROSSI, an LCN "member" of the Texas "Brugad" by Los Angeles LCN "Capo" ANGELO POLIZZI. Informant had not seen PATRONO since and was not currently in a position to be familiar with PATRONO's activities. LA 4448-C-TE is a "member" source of the Los Angeles Office who furnishes on a continuing basis extensive information concerning LCN and related matters.

The changed title does not include the names JOHN RUSSO or JOHN ROSSI, as these names were the recollection of an introduction of several years past, and they have not appeared from other sources as names used by PATRONO.

Careful consideration has been given to each source concealed and T symbols were utilized in this report only in those instances where the identities of the sources must be concealed and where the sources have so requested that their identity be concealed.
