The long period date in this report is noted. The Bureau was advised of details relative to PELLEGRINO's move from New York to Dallas in referenced letter. Dallas requested office of origin be changed from New York to Dallas and Dallas was designated new office of origin by return copy of letter received by Dallas 3/25/60. There has been very little activity on PELLEGRINO's part since he was arrested shortly after his arrival in Dallas by the Dallas PD Vice Squad, charged with vagrancy, and interviewed relative to his reason for moving to Dallas. This case is receiving continuous investigative attention at Dallas and regular reports will be submitted relative to PELLEGRINO's activities.
