DAILY SUMMARY. CG 6486-C* ADVISED OVER LABOR DAY WEEKEND OF THE PRESENCE OF SEVERAL OF CHICAGO'S BETTER KNOWN HOODLUMS, INCLUDING GIANCANA, JACK CERONE, DOMINIC BLASI, JOHN MATASSA, FELIX ALDERISIO, AND OTHERS NOT IDENTIFIED. ONE OF UNKNOWNS, WHO APPEARED DURING EARLY EVENING OF SEPTEMBER 1 LAST, IS A POLITICIAN WHO WAS ORDERED AT THE TIME, OUT OF POLITICS FOR AN UNKNOWN REASON. GIANCANA HELD A GENERAL BULL SESSION WITH THESE INDIVIDUALS, HOWEVER, NOTHING OF SIGNIFICANCE WAS NOTED, EXCEPT THAT GIANCANA WAS HIGHLY IRRITATED OVER SOME SITUATION, APPEARED TO BE GENERALLY DISSATISFIED. CG 6533-C ADVISED INSTANT THAT GIANCANA APPEARED THIS DATE AT ARMORY LOUNGE. u
