Re Paris letter 7/25/63. U

The Police Judiciaire (Criminal Police), Surete Nationale (PJSN), has now advised the Paris Office that inquiries conducted in France have failed to reveal any trace of subject's passage through this country. French source advised that a general notice concerning the subject, including his photograph, has been sent out to appropriate posts of the PJSN and has assured that in the event subject visits France, his visit will be brought to the attention of the Paris Office. (S)

Inasmuch as no further information has been received from the French authorities in this matter, instant case is being closed in the Paris Office subject to prompt reopening in the event pertinent data is in the future received from the French authorities. (S)
