ADMINISTRATIVE:

On 11/27/72, DL 1251-PC advised SA F. VINCENT CESARE that he bet with MILLER and MILLER has given him symbol number 66. He stated MILLER is associated with JOHNNY STONE. He stated he places bets with MILLER by calling 363-5166 and he settles up with MILLER on Tuesdays at the Chateau Briand Restaurant on Mc Kinney. Source stated that at times he would just leave an envelope or pick one up at the restaurant. Source stated he called MILLER on Saturday, November 25, 1972 and MILLER's wife told him that MILLER had a heart attack and was in the hospital.

DL 845-C-PE advised SA F. VINCENT CESARE on 12/4/72, that ISADORE MILLER heard that the "heat" was on. This being a reference to law enforcement and had , gone into the hospital on 11/25/72. Source said MILLER remained in the hospital and he believes that the hospital is Doctor's Hospital on Garland Road. Source stated that he does not know if MILLER is continuing bookmaking from his room at the hospital.

Mrs. VIRGINIA ADAMS, Southwestern Bell Telephone Company, advised on 12/12/72 that she had requested long distance telephone tolls for the subject's residence phone, but as of that date, these tolls were not available.
