On February 24, 1971, an official of the Israel National Police (INP) revealed that INP records note that Leo Meyer Ogul, father Sam Ogul, first arrived in Israel on April 18, 1970. Following that arrival date he departed Israel (destination unknown) on May 20, 1970. He proceeded to Israel on April 18, 1970, from Teheran. INP records also note Ogul was born on May 17, 1921, at Chicago, Illinois. His United States residence is 4936 Finley Avenue, Los Angeles, California. He is traveling with Passport Number G 996599.

Following his departure from Israel on May 20, 1970; Ogul again arrived in Israel on July 15, 1970, indicating on his arrival that he would reside at the Sheraton Hotel in Tel Aviv. He again left Israel on December 3, 1970 (destination unknown) and returned on December 7, 1970, where it is assumed, according to INP records, that he still resides at Frug Street, #5, Tel Aviv. He is a temporary resident of Israel and has been issued an Israeli Identification Card.
