Israel for the third time 12/14/70, and there is no record in Israel of his departure. MEDLEVINE on 12/14/70, was granted a temporary residence visa and was issued a Israeli Identification card.

The LHM also advised that there is no such hotel in Tel Aviv as the King Edward Hotel.

The LHM also revealed that LEO OGUL is currently residing at Frug Number 5, Tel Aviv, Israel.

A copy of this report is being furnished the Chicago Office in view of the fact that they have outstanding leads to interview FELIX and DON JO MEDLEVINE.
