In view of the fact that both OGUL and MEDELVINE have been located in Tel Aviv, Israel, this matter is being placed in a pending inactive status for six months. After six months this case will be re-opened and an appropriate letterhead memorandum submitted requesting the Legat, Tel Aviv to again verify their residence in Tel Aviv.

Appropriate stops have been placed with the Immigration and Naturalization Service, New York, on 3/3/71, for both OGUL and MEDELVINE.

On 1/13/72, the Bureau furnished a copy of a letterhead memorandum from the Legat, Tel Ayiv dated 12/29/71, to the affect that MEDELVINE resides on Trumpeldor Street, number not known, Tel Aviv, Israel.

On 1/12/72, CG 6830-C furnished information to the Chicago Office to the effect that DON JO MEDEL-VINE in August 1971, indicated that his brother "FRENCHIE" was in Israel and did not intend to return to the United States to go to jail because he was too old and would die in prison.
