ADMINISTRATIVE:

For the information of Legat, Rome, LEO MEYER OGUL was born on May 1, 1921, at Chicago, Illinois. His father is SAM OGUL. LEO MEYER OGUL was issued U. S. Passport Number G996599, and entered Israel April 18, 1970, subsequently departing May 20, 1970. On July 15, 1970, he re-entered Israel with the above passport, indicating his address in the United States as 4936 Finley Avenue, Los Angeles. As a result of his registration as an immigrant, OGUL was given Israeli Identification Card Number 1260590. Background with regard to OGUL's fugitive status is not available to this office; however, MEDLEVINE, who is currently residing in Israel, has the following background, which is the basis for his fugitive status: *(X)(u)*

On September 11, 1970, a Federal Grand Jury at Los Angeles returned an indictment charging MEDLEVINE with one count of conspiracy, Title 18, U. S. Code, Section 371, and 17 counts of interstate transportation of stolen property, Title 18, U. S. Code, Sections 2314 and 2315. A bench warrant was issued by a U. S. District Judge at the same time.

MEDLEVINE was arrested by Bureau Agents on September 29, 1970, at Chicago, Illinois. On December 15, 1970, he failed to appear as scheduled in U. S. District Court, Los Angeles, and a bench warrant was issued by U. S. District Judge MANUEL REAL, charging MEDLEVINE with bond default, Title 18, U. S. Code, Section 3150. He is described as follows:

Contact maintained with Israel National Police (INP) has revealed that agency's reluctance to place stops for individuals entering or leaving the country, since INP personnel utilized at the border control sections of international entry points are not in a position to maintain and appropriately utilize a system of stops when these numbers become in any way extensive. INP, however, is willing to place a "stop" in their border control records at INP Headquarters in Jerusalem, so that when the frontier notification of a departure or entry reaches border control records at INP Headquarters in Jerusalem, a notation in the file will alert the person filing the departure or entry notification to call this action to the attention of his superior. This process would result in the stop being effective anywhere from a week to ten days following the departure or entry of an individual of interest. For this reason, no stop was placed on subject OGUL, but, because of his departure from Israel and the possibility of MEDLEVINE following suit, INP is being requested to place a stop on MEDLEVINE.
