On 8/14/67 CV 654-C-TE advised that WILLIE and SIDNEY KOLOD would be the only likely individuals in the Cleveland area to attend funeral services in Las Vegas for their brother, RUBY KOLOD, Las Vegas gambling figure. Source advised a relative of JOHN T. SCALISH, Cleveland LCN leader and Apalachin attendee, was married within the past week or so but advised he has been unable to ascertain the identity of this relative.

On 8/15/67 source advised he had learned that NEVADA GEORGE GORDON, Las Vegas gambling figure, was not going to attend MORRIS KLEINMAN's (Las Vegas gambling figure) 50th FLA. anniversary at the Somerset Inn, Shaker Heights, Ohio. He stated he understood Mrs. YALE COHEN, wife of YALE COHEN (Miami gambling figure), presently in Cleveland for the anniversary party, had cancelled GORDON's reservations at the Somerset.

On 8/18/67 CV 790-PC advised that FRANK SCALISH, son of THOMAS SCALISH (former Cleveland hoodlum) and brother of JOHN T. SCALISH, (Cleveland LCN leader and Apalachin attendee) was married a month ago in a civil ceremony by a
