Re Las Vegas airtel to the Bureau dated 7/10/62.

MORRIS BARNEY DALITZ, aka, one of the principal stockholders Desert Inn and Stardust Hotels, was interviewed on 7/12/62 by SA's M. B. PARKER and ARTHUR N. BARRETT. At that time he furnished information concerning his recent trip to Europe and his difficulty in clearing through U. S. Customs upon his return. Full information concerning interview is set forth in Las Vegas airtel of 7/21/62 in matter entitled, "CRIMINAL INTELLIGENCE PROGRAM, LAS VEGAS DIVISION, WEEKLY AIRTEL SUMMARY", Bufile 62-9-65.

DALITZ was subsequently interviewed on 7/31/62 by SAC DEAN W. ELSON and SA M. B. PARKER, at which time DALITZ made observation concerning the forthcoming election in Las Vegas. DALITZ also stated that he intends to more or less retire from day-to-day involvement of the Desert Inn and Stardust group operation following the general election in November, regardless of which side wins.
