On 9-21-59, Mr. JOSE M. BORRERO, Economic Section of the Embassy introduced a Cuban friend, GUSTAVO ALEMAN, who had just been released from Castillo Atares Prison. ALEMAN stated that although he did not see MARTINO the last week he was in prison, he knew that MARTINO continues to be imprisoned and is not receiving proper medical attention for some kind of nephritis. Mr. HUGH D. KESSLER, Protection Officer of American Embassy advised on 9-24-59, that he is aware of MARTINO's condition; his principal (1) trouble appears to stem from the fact that he is a dope addict On 10-12-59, the Embassy advised it would like to know if there is any arrest record for the Subject in the Identification Division of the Bureau. On 10-13-59, HAV 32 was requested to check and see if prints of Subject are available in the Gabinete Nacional de Identification, (National Identification Bureau) and secure a copy or photo of the same. prints are secured, they will be furnished the Bureau. However if it is requested that the Bureau please furnish in duplicate any record identifiable with the Subject under name check. As of possible assistance, Subject stated he was born 8-3-11, Atlantic City, New Jersey, is an Electronics Engineer, owns two businesses at 32 and 38 41st Avenue, Long Island, New York; he has identified these as the Neptune Engine Company and the Radio Page Company.
