ROBERT BERNARD BAKER, AKA, LMRA DASH IM. REBUAIRTEL JUNE  
TWENTY LAST. THIS MATTER DISCUSSED WITH USA AMMERMAN, PITTSBURGH  
THIS DATE. HE BELIEVES THAT INDICATIONS DEVELOPED TO DATE  
OF UNAUTHORIZED TRAVEL BY BAKER WILL SUPPORT A PETITION  
TO THE COURT FOR REVOCATION OF HIS BOND. HE WISHED TO HOLD  
ACTION UPON SAME IN ABEYANCE HOWEVER IN VIEW OF FACT IBT  
GENERAL CONVENTION IS SCHEDULED TO BE HELD IN MIAMI JULY  
THREE THROUGH TEN NEXT AND HE FEELS BAKER WILL IN ALL  
PROBABILITY ATTEND. IF SO, AND IT CAN BE BROUGHT TO  
THE COURTS ATTENTION THAT HE IS THEN AND THERE TRAVELLING
