On January 25, 1960, Plato Cacheris and Abraham Poretz, Department of Justice attorneys, held a conference concerning the accounting examination of the records of Exhibitors Service Company with Special Agent Edward W. Pennypacker. During the conference reference was made to the fact that the moneys sent by the company to Weinheimer were transmitted via the minimum air mail and regular mail postal rates. In this connection, Cacheris and Poretz requested that consideration be given to a test being made by the Federal Bureau of Investigation to determine whether twenty used bills of any denomination and a business size envelope, as well as a letter size piece of paper or a small envelope either of which might have been utilized as enclosures with the money, could have been sent through the mails for the minimum postal rates.

Inasmuch as such a determination would be a matter primarily a function of the postal authorities and not the Federal Bureau of Investigation, no action in this regard is being taken in absence of any further request.
