[redacted] voluntarily furnished the information set forth in the LHM as a result of reported apprehension of an airline pilot whose aircraft and numerous small arms aboard it were confiscated by authorities somewhere in vicinity of Albany, Ga. [redacted] felt that this could be a revival of the plan to bomb a Russian ship approximately one year ago and wished to give this information to the Federal Government for any action they might want to take.

[redacted] advised that he will continue to furnish additional information concerning Cuban activities in the Atlanta area.
