Re London let 6/30/61, requesting the Bureau to advise if any information is available denoting whether or not GREENDLINGER is in a travel status.

By letter dated 7/10/61, classified Confidential, British Security Service MI-5, advised there is still no trace of GREENDLINGER having arrived in the United Kingdom. MI-5 observes, that if GREENDLINGER still plans to study at Manchester University, it may be he will not come to the United Kingdom until September, in time for the start of the new scholastic year. (C)

The Bureau is requested to furnish any information which might substantiate MI-5's observation. (C)
