The following information was further reported by DL 146-C on 6/26/68, and is being recorded on the cover pages to further protect the informant.

CI advised that subject had attempted to buy a car from his agency through his salesman AL MEADOWS and went to MEADOWS' desk and located the papers dealing with the matter. CI advised the deal fell through because DOLAN's credit as well as his co-signer were not good enough. DOLAN furnished the following background as revealed by the papers made available by informant:

Age 53, residence 5509 Caladium, phone EM 8-3471, previous residence 4007 Druid Hill, employment Sales Representative, LaSalle Extension University, Chicago, Illinois, previous employment Forest Lane Produce (truck driver), wife MARIAN, daughter CATHERINE DOLAN, 1275 Fairfield, Reno, Nevada.
