The investigation to establish subject as the perpetrator of the SHEILA MC RAE jewel and fur theft, Lake Geneva, Wisconsin, 2/21/69, continuing. Subject believed possibly to have been involved in Seattle armed robbery of JOE GASPARAVICH. Subject's ex-wife had long distance telephone call from subject on Thanksgiving, but he did not indicate his whereabouts.

#### DETAILS:

On November 14, 1969, T-1 advised that her husband had just returned from Seattle, Washington, on a business trip and had learned that JOE GASPARAVICH and his family had been robbed at his home approximately one year ago by two armed men wearing masks. The two men broke into GASPARAVICH's home, forced their daughter to remove her clothes, tied her up, then waited for GASPARAVICH and his wife to return.

T-1 recalled subject DOLAN discussing such a robbery in her presence indicating how he had undressed the girl and ate a bowl of ice cream while he waited for the family to return. Informant earlier advised that she had seen DOLAN in possession of masks and guns.
