ARTHUR CUMMINGHAM, Miami tax attorney who has been representing SANTO TRAFFICANTE in the Old Tampa IRS case, has messed up the case badly and since the death of Tampa accountant DAVID SCHWARTZ, the case is in even worse condition than before.

Attorney PAUL LOUIS who has been representing EVARISTO GARCIA SARMIENTO says that he will no longer handle them after the current Federal case in Miami. He has also moved out of the libel case against Time Inc., for FRANK RAGANO who is now being represented by MELVIN BELLI.

EUGENE/KLIGMAN, former accountant for OAKLEY SMITH at the Paim Springs Hospital in Hialeah, <u>Florida</u>, is now in Brooklyn where he has a large medical clinic specializing in abortions.

On September 22, 1970, MM 635-S who has knowledge of activities of Cuban revolutionaries in the Miami area as well as some knowledge of criminal activities of Cuban personalities in this area, advised as follows:

At approximately 10:25 AM, September 22, 1970, he observed three individuals emerging from Howard Johnson's Motel and Restaurant facilities located at Biscayne Boulevard and 11th Street, Miami, Florida. They departed on the west side of the building and entered the sheltered garage area. He recognized one of these individuals as a Cuban who had been an official in the Cuban Government during the regime of former Cuban President CARLOS PRIO SOCARRAS. On September 24, 1970, MM 1311-C-TE advised that SANTO TRAFFICANTE had spoken yesterday by telephone with RITA GARCIA at her home. RITA plans to leave for San Jose, Costa Rica, on September 25, 1970, to join her husband, TRAFFICANTE associate, EVARISTO GARCIA VIDAL.

On September 25, 1970, MM 1401-C-TE advised that during the prior week SANTO TRAFFICANTE was in need of some immediate cash and JOE ROSATO gave him \$15000 which ROSATO obtained from his bank on the corner of 96th Street and NE 2nd Avenue, Miami Shores.
