Enclosed herewith are nine copies of a letterhead memo setting forth information furnished by the Subject, who appeared voluntarily at the San Francisco Office on 11/21/60.

One copy of the memo is enclosed for Miami since the Subject mentioned individuals residing in that area.

It is noted that the Subject stated that he had no connection with intelligence or police organizations while in Cuba. He intends to ask for political exile in the U.S. until such time as there is a change in the Cuban regime.

Since the Subject is new in the San Francisco area, it does not appear that he has potential as a source at this time. He was told to clarify his status with INS which he intended to do on 11/22/60. He stated that should he become identified with any organizations, he will advise this office. If it appears that he may have informant potential in the future, a proper communication will be submitted to the Bureau requesting authority to contact him as such.
