He stated that he would make inquiry in an effort to ascertain if MATULA departed San Francisco on 9/8/62 with a large sum of money to be delivered to HOFFA. On 6/7/62, the informant advised that he was unable to obtain any information concerning this matter or about MATULA's contacts while in San Francisco during the pertinent period.
