LA 4350-C has advised that STEVENSON is presently semi-retired and that STEVENSON's office in Los Angeles is currently being run by Attorney CHARLES K. HACKLER. Further, that STEVENSON is holding approximately 80% of MATULA's cash and that STEVENSON has a boat in Honolulu where informant suspects that the currency may be hidden.

Bureau desires that STEVENSON be interviewed in detail for all information he may be able to furnish concerning MATULA's activities and particularly regarding the information furnished by LA 4350-C. Extreme caution should be used in these interviews in order that the original source will not be disclosed.

Source was at one time connected with the Teamster movement in Los Angeles and in that capacity would have frequent contact with STEVENSON and STEVENSON at one time represented source. Bureau has instructed that two mature SAs conduct this interview.

Attempts to contact STEVENSON at his Los Angeles residence, which is 342 Paseo del la Playa, Redondo Beach, California, telephone FR 8-5589, have been made with negative results.

STEVENSON purportedly owns the apartment house at this address and resides in Apartment 4.

Mrs. MARY WOOLEY, who resides in Apartment 1, advised that she is forwarding mail to STEVENSON at the Kalia Apartments, No. 304B, 425 Ena Road, Honolulu, Hawaii and that STEVENSON is in Honolulu on business and is not expected to return to Los Angeles for several months.

Honolulu with interview STEVENSON to develop any information in his possession in the event STEVENSON is willing to furnish information.
