The Bureau desires to point out that even though the informant may now appear more at ease with the Agents and more trustful of them, you should still continue to exercise extreme caution in your conversations with him so you will not disclose information in Bureau files during the course of these conversations.

With respect to the suggestion contained in the penultimate paragraph of reairtel you are advised that it is not felt that dissemination of information received from the informant can be held in abeyance until the conditions of this suggestion are completely fulfilled in all instances. As you undoubtedly have observed from various communications received from the Bureau regarding the information received from this informant, dissemination is being made to the Department of Justice promptly of those matters concerning which it is believed prompt dissemination is required. It is being delayed in other instances until more specific facts can be obtained by your office from the informant. It is expected that this practice will continue to be followed in the future.
