REURAIRTEL ONE NINETEEN SIXTY TWO. BUREAU BELIEVES THAT ANY SUBPOENA FOR RECORDS OF TEAMSTERS UNION SHOULD BE SERVED BY U. S. MARSHAL. BUREAU AUTHORITY NOT GRANTED FOR SPECIAL AGENTS TO SERVE SUBPOENA. BUREAU HAS NO OBJECTION FOR TWO MATURE AND EXPERIENCED AGENTS TO CONTACT MATULA TO REQUEST VOLUNTARY ACCESS TO RECORDS PROVIDING NO INFORMATION IN YOUR FILES TO INDICATE SUCH CONTACT INADVISABLE. DISCUSS WITH AUSA IN LIGHT OF THESE INSTRUCTIONS AND SURAD TODAY RESULTS OF THIS DISCUSSION. INCLUDE RESULTS OF DISCUSSION ONE TWENTY TWO LAST WITH AUSA RELATING TO PROCEEDING IN VIEW OF STRIKE REFERRED TO RE AIRTEL.
