KC 284-C advised that ROY LEE WILLIAMS, Chairman of Joint Council 56, Teamsters Union, contacted NICHOLAS CIVELLA and the two decided who the Clique and Teamsters would back in the next political election in Kansas City. According to this source, neither the Clique nor the Teamsters will be back of Judge JOHN KOPP. According to this source, CIVELLA and WILLIAMS had this discussion in order to determine if the same candidates would be agreeable to both the Clique and the Teamsters and that neither wanted to back a candidate that either was opposed to.

Mr. BERTRAM WANSTREET, INS, KCMO, advised that investigation has disclosed that THOMAS FONTANELLO, FBI #344518, and NAGEL JOSEPH MAROON, FBI #472766, have been determined to be aliens and are susceptible to deportation. A separate communication to the Bureau will be forwarded concerning this matter.

The Las Vegas Division advised that investigation disclosed THOMAS CACIOPPO, aka Thomas Morgan, FBI #679492, a member of the Clique, was at the Riverside Hotel, Reno, Nevada from 6/13 to 6/15/62. Reservations were made by LEWIS JOSEPH McWILLIE, born 5/4/08, Kansas City, FBI #4404064, who is gaming manager of the Riverside Hotel. The purpose of this trip has not been ascertained to date.
