Enclosed for the Bureau, San Francisco, San Antonio are two copies of an FD-302, reflecting voluntary interview of HOMER VIRGIL NOBLE, At Reno, Nevada, 3/20/69. One copy is enclosed for assistance of Dallas, Little Rock and Oklahoma City.

By way of summary of investigation conducted to date, SF-3190-PC has furnished information alleging interstate gambling activities on the part of subjects HOMER NOBLE and TOM MOORE. Information was first furnished in 10/68, that MOMER NOBLE operated one of the largest gambling operations in San Antonio, Texas; that he is a partner of TOM MOORK, owner of the Holiday Hotel, Reno, Newada; that "the illegal operation spans several states and has the backing of 'international Jewish syndicate' and 'Italian syndicate'"; that NOBLE exercises considerable control over the Holiday Hotel; that MOORE and NOBLE can be located in San Antonio, Texas, three weeks out of four; that NOBLE is a "juice man" for the Jewish syndicate and is paid \$50,000 a year by them.

from independent sources indicating that NOBLE had no interest whatsoever in any San Antonio gambling establishments, it appeared that information received from the San Francisco informant was not correct.

On 10/3/68, NOBLE was interviewed at Reno, Nevada regarding his association with SLIM LAMBERT, at which time NOBLE advised that LAMBERT had no out-of-Texas gambling interests and that LAMBERT was not connected with any socalled hoodlum elements.

Regarding the attached interview of NOBLE, it should be pointed out that TOM MOORE has informed Nevada Gaming Control Board that following the NGCR approval of sale of the Holiday Hotel, MOORE will return to Texas and he has no further plans to become involved in garbling matters in the state of Nevada.

Some allegations regarding gambling activities of HOMER NORLE and TOM MOORE as furnished by San Francisco source appear to be incorrect. It is noted that HOMER NOBLE voluntarily contacted FRI, Reno, and furnished information refuting allegations by San Francisco source. It appears that HOMER NOBLE, CAROL NEFF and VINCENT HILLYER are involved in a marital triangle and that possibility exists that NEFF and HILLYER are attempting to derogate NOBLE due to strained personal relationships. NOBLE'S situation was further aggravated by the internal turmoil that has existed at the Holiday Hotel in Reno, which appears to be a struggle between the Texas owners—management and the Reno, Nevada employees.

Las Vegas division recommends that San Francisco Division consider reporting information furnished from SF 3190-PC submitting in future, communications under appropriate separate captions rather than under instant captions.
