Re Bureau letter to Las Vegas, 11/11/71.

Enclosed for the Bureau is the original and five copies of a LHM entitled "LEWIS JOSEPH MC WILLIE". Two copies of this LHM are enclosed for Las Vegas.

The first reliable source mentioned in the LHM is MISS BIRDIE SUE BELCHER, Retail Merchants Credit Association, Dallas, Texas, contacted by SA ROBERT P. GEMBERLING on 11/9/61.

The second reliable source mentioned in the enclosed LHM is DL 91-C, contacted by SA ALBERT D. NEELEY on 12/29/58.

The Las Vegas Office is furnished copies of Dallas LHM to insure that Las Vegas is aware that the Dallas LHM does not include information contained in Salt Lake City letter to Dallas of 11/25/53 captioned "LESTER BENJAMIN BINION aka Bennie Binion", which letter reflects MC WILLIE's association early in 1946 with BINION and MC WILLIE shot and killed GEORGE ARTHUR MC BRIDE in an attempted holdup. MC BRIDE reportedly had a gun in his hand. MC WILLIE was not billed by the grand jury.
